## Monthly Giving

### Why give Monthly?

- Monthly giving allows for funds to come into the camp *year round* which allows us to do *better financial planning* and therefore we are able to best use the resources that God entrusts to us.

### Giving options:

Adopt a <b>DAY Camper</b> ----->	\$15/month
Adopt a <b>OVERNIGHT Camper</b> ----->	\$20/month
Adopt a <b>Camp Family</b> (2 day camp and 2 overnight camp) ---->	\$70/month
Adopt an <b>Entire Cabin</b> (total of 10 campers) ----->	\$150/month
*Amounts come from estimated cost of having a camper at camp and you can change your monthly giving at anytime
